Letter from the President and CEO

The Osborn hummed with energy and engagement throughout 2024, making it one of our most vibrant years yet.

Resident move-ins were at an all-time high—a powerful testament to the warm, welcoming, and dynamic community we have created. A major highlight was the debut of a beautiful new social amenity space, quickly embraced as a favorite spot for residents and their guests to connect over coffee, games, or live music. At the heart of The Osborn's success is our dedicated staff, who continue to foster a caring and exceptional environment—an effort deeply valued by our residents.

Reflecting on the past year, I feel immense pride in what we have accomplished and great excitement for what lies ahead.

We also welcomed many visitors who came to experience the wide range of programs The Osborn has to offer. Our signature WellSpring Series remained a major draw in 2024, with acclaimed author talks featuring Martha McDowell, Claire McNear, Joseph W. Polisi, and Max Tucci. We were delighted to host two outstanding performances by Orchestra Lumos. Residents also actively joined in seasonal celebrations like Dog Days of Summer, Monte Carlo Night, and Mardi Gras.

Outdoor events—including the Spring Fashion Show, summer barbecues, and the John Sterling Putting Tournament—brought even more vitality to campus life.

Our connection to the greater Rye community grew even stronger. We partnered with the Osborn School on intergenerational events such as Flag Day, a Halloween Parade, and a holiday concert. Collaborations with local organizations—including Rye Seniors, Rye YMCA, Rye Nature Center, and SPRYE—further enriched our shared experiences through community walks and programs across our scenic arboretum campus. Our management team volunteered 1,594 hours to community organizations.

We are especially grateful for the generous philanthropic support received through The Osborn Foundation. In 2024, resident contributions to our Employee Enrichment Fund and Academic Achievement Awards grew significantly. We also saw record-level support from our business partners. The Foundation was able to extend support to 26 nonprofit organizations throughout Rye and the surrounding region.



This year, we served hundreds of people in Rye and surrounding communities through our various levels of care, including 612 individuals through Osborn Home Care, 623 in The Pasciuti Pavilion skilled nursing facility, and 277 through outpatient rehabilitation. We were honored to receive several prestigious accolades, including: *Best of Westchester Best Senior Residence* by *Westchester Magazine*, recognition among *America's Best Continuing Care Retirement Communities* by *Newsweek*, and designation as a 2024 *Best Nursing Home* by *U.S. News & World Report*.

These achievements would not be possible without the dedication of our Board of Trustees, the leadership of our management team, the compassion of our staff, and the ongoing support of our residents and donors. It is a true privilege to lead this remarkable organization, and I am grateful for your continued commitment to The Osborn Foundation.

The Miriam Osborn Memorial Arboretum



Under the guidance of John Sterling, co-founder of The Osborn, our campus opened in 1908, designed with graceful walking paths, open lawns, and over 1,000 trees. Thanks to the dedicated care they've received, many of these original trees still stand today, offering beauty and tranquility to residents, staff, and visitors alike.

Today, our 56-acre campus is home to approximately 1,000 trees, representing 132 different species. This rich natural environment plays a vital role in our wellness philosophy, providing a peaceful, restorative setting for everyone who spends time here. The trees of The Osborn are more than just landscape—they are a living legacy that enriches the daily lives of our entire community.

In recognition of our efforts, The Osborn received Level 1 Accreditation from the ArbNet Arboretum Accreditation Program in February 2020. The Miriam Osborn Memorial Arboretum is proud to be the only private arboretum in Westchester County.

Thanks to your generosity in 2024, we continued our vital work in preserving and enhancing the arboretum. Your support helped us: (1) prune, fertilize, and protect trees from disease, (2) plant new trees to increase species diversity and maintain ecological balance, and (3) monitor and care for trees that could pose risks to safety or property. We also expanded our educational efforts by labeling more trees, updating shared maps, and offering guided tours. Notably, we planted 30 new trees in 2024, including eight newly introduced species.
